## **REGISTRATION REQUIREMENTS**

To qualify for registration as a Spotted Saddle Horse, the horse must possess one spot above a level line, midway between the center of the knee & the floor of the chest & midway between the point of the hock & center point of the stifle. If a horse has only a high stocking or an extended face marking, then it must exhibit a spot of 2 inches in diameter or more, or the tail must exhibit contrasting color & skin of 2 inches or more. Facial markings do not count.

A horse must satisfy all existing qualifications for registration & must additionally be a product of either a SSHBEA registered tobiano sire or SSHBEA registered tobiano dam. Tobiano is defined to be a horse that has the appearance of phenotype which is indicative of a horse that has the tobiano gene.

All horses must exhibit a smooth, easy saddle gait other than a trot (such as single-foot; running walk; rack; stepping pace, etc.). All horses must be inspected for gait by a SSHBEA inspector or a video showing horse in motion. **Exception (Effective 11/9/2015):** Inspection for gait or video requirement is NOT required for SSHBEA-to-SSHBEA or SSHBEA-to-acceptable cross breeds which are registered on gait.

<u>Cross breeding with gaited breeds</u>, such as Tennessee walking horses, racking horses, mountain horses, & gaited spotted horses, is allowed and does *not* require video or inspection *IF* a copy of the horse's registration papers are provided.

<u>Cross breeding with NON-gaited breeds</u>, (such as American Saddlebreds, Quarter Horses, Arabians, Pintos, etc.) does require a video to be submitted with the application for registration *OR inspection* for gait by a SSHBEA inspector.

Any person who shall willfully register or record a false pedigree shall be forever barred from making further registrations, & the registration of such false pedigree shall be denied or voided.

The signature of owner of both sire & dam are necessary to complete an application & must be signed in ink.

All applications for registration must be typed or in ink. These applications are an important permanent records of the Association. Every care should be exercised in giving dates, markings, etc.

Transfers are required with applications for registration of foals when the dam of the unregistered foal was owned at a time of foaling by someone other than the owner at the time application for registration of the foal is submitted.

Transfers must be attached to such applications for registration, date of purchase filled in, & fees remitted for both registration & transfer.


