## DIRECTIONS FOR TRANSFER OF OWNERSHIP

1) The seller of a SSHBEA registered horse shall, within thirty (30) days after the purchase date, report the sale to the Association Office in Shelbyville, Tennessee, and pay the designated fee. The Association will then deliver the papers to the new owner.

2) *All writing must be in ink.* Do NOT use lead pencil.

3) *If you make a mistake, use a new form.* Erasures or names, dates, or signatures that have been scratched out and/or rewritten are NOT acceptable and void the document.

4) *Print* clearly the name and full mailing address of the buyer.

5) *Print* clearly the name and registration number of the animal to be transferred.

6) *Enter the actual, true date of sale.*

7) The *seller must personally sign* his/her name in the space provided and include a complete mailing address. *Printed signatures are NOT acceptable.* If the horse is jointly owned, all sellers must sign individually.

8) If the transfer is for a mare that was served prior to date of purchase but had not yet foaled, the name and registration number of the stallion and the date the service must be provided, and the owners of both stallion and mare on this service date must personally sign their names on the designated lines and indicate whether or not the service fee has been paid. *Foal cannot be registered until the service fee is paid.*

9) Send the correct fee WITH the transfer request.
